Visit Sites Honoring Smith-Lever Act Sponsors

Consider visiting some of Extension's historic sites as we approach the centennial observances of the signing of the founding legislation for the Cooperative Extension Service. The Smith-Lever Act, signed on May 8, 1914 by President Woodrow Wilson, made Extension available nation-wide. Two landmarks for the trek could be historic plagues in Georgia and

South Carolina recognizing the bill sponsors Michael Hoke Smith and Asbury Francis Lever.

Michael Hoke Smith



To view a plaque honoring Michael Hoke Smith go to the Courthouse at Burke County, Waynesboro, Georgia in the greater metro-area of Augusta. The historic

plaque outside of the 1857 courthouse recognizes Smith and nine other former Georgia governors who have Burke County connections.

After being governor, Smith was appointed and later elected to United States Senate in 1911. He piloted the Extension creation legislation in the Senate. The Hoke Smith Building and Annex on the campus of the University of Georgia in Athens, house some of the offices of the Cooperative Extension Service. Prior to entering politics Smith was owner of a prominent newspaper in Atlanta. There is a brief bio of Smith in the Georgia Agricultural Hall of Fame Website for 1985.

Smith combined efforts with Asbury Francis Lever in the U. S. Congress to sponsor the bill. Congressman Lever was a member of the South Carolina House of Representatives prior to his election to Congress representing South Carolina. The historic marker, honoring Lever, is

located on the Campus of Clemson University, Clemson, South Carolina near the entrance to the cemetery on Cemetery Hill.

There is an Epsilon Sigma Phi ensign engraved on his grave marker. ESP National President Deborah Thomas reports that

cleaned-up the gravesite. Biographical information about Lever is available on the Clemson University Website.

Rasmussen's book, TAKING THE UNIVERSITY TO THE PEOPLE - SEVENTY-FIVE YEARS OF COOPERATIVE EXTENSION. This 1989 book is available for sale with used book dealers on the Internet. Many Extension professionals have copies in their personal collections. Appendix D is the actual text of the original Smith-Lever Act. Preceding it in Appendix A is a listing of Distinguished Service Ruby Award Winners from 1927 - 1988.

Recognition Applications and Scholarship Applications Due Soon!

March 1st is your last chance to submit recognition applications and scholarships. The recognition applications for Distinguished Service Ruby, National Friend of Extension, Regional Distinguished Service, Regional Administrative Leadership, Regional Continued Excellence, Regional Mid-Career Service, Regional Early Career Service, Regional International Service. Regional Visionary Leadership, Regional Multicultural Diversity Individual, Regional Multicultural Diversity Team, and Distinguished Team are due March 1st. The applications must be entered on the online web forms found at Recognition-Applications-Reports Tab. State

recognition chairs must remember to submit a National Recognition Nomination Submission Form to identify those applications that are being forwarded by the chapter for consideration for national or regional recognition.

Chapters will be notified of the applicants being considered for regional recognition by April 1st. The chapters will have until May 15th to submit their ballots for the recognition applicants in their region as well as for the Distinguished Service Ruby applicants and the National Friend of Extension applicants. Now is the time for chapters to begin planning on the procedure that you will use to cast your

ballot for the recognition applicants. Chapters will each cast one ballot; however, the ballots will be weighted based on the membership numbers as of February 1, 2011.

The Richard R. Angus Professional
Development Scholarship and the
Administrator/Leader Scholarship
applications are also due on March 1st.
These applications and additional
information are also found at the
Recognition-Applications-Reports Tab.
Selection of the recipients of these
scholarships will be announced by May 1st.

2. Authors will only be able to be listed as a lead author on one RFP proposal (concurrent or poster, not both). This will enable more authors the opportunity be accepted for either a concurrent or poster session.

Stipends for Concurrent Session and Poster Presenters:

- Concurrent Session presentations are eligible for a \$200 stipend.
- \$100 Poster Presentation stipends are offered for up to ten posters based on a conference site selection process.
- Presenters can claim only one stipend (concurrent session, poster, delegate, committee member or life member).

<u>Remember...Only Concurrent Session and Poster</u> <u>presenters who attend the full conference are eligible</u> <u>for the stipends.</u>

The Alpha Kappa Chapter Provides Extra Opportunities for Its Members

The Alpha Kappa Chapter of Kentucky is dedicated to expanding interest in Epsilon Sigma Phi and increasing its membership. To create some competitiveness among the seven Extension districts, a catered meal valued at \$600 was promised to the district having the largest percentage of potential members. Extension professionals having three or more years of experience are eligible to join the Kentucky chapter.

In an effort to provide service to its membership, the Alpha Kappa Chapter is offering an Extension Leadership Development In-Service Training session the day prior to the chapter's annual meeting. This is the second year this strategy has been used to encourage attendance at the annual meeting.

The in-service will feature Elizabeth Crook, President of Orchard Advisors, who works with organizations and individuals who are changing the world by tying their values to action. Ms. Crook is knowledgeable of the Extension system, having worked with University of Tennessee Extension in their strategic planning process. The Epsilon Sigma Phi in-service will give members an opportunity to learn how resistance to change plays out in their own lives, how to use the Emotional/ Rational Connection and to develop practical approaches to being more effective in helping others to change.

The evening program provides members with an opportunity to learn about incorporating local foods into a fine dining restaurant plus how a small community built a nationally recognized community arts program. A three course meal featuring seasonal foods from local farmers will be served at a facility listed on the National Register of Historic Places.

The Alpha Kappa Chapter Annual Meeting and Awards Program will be held on day two. The Annual Meeting will include a Life Member session, a silent auction, plus networking and poster sessions.

- Continue effective communication with the National Board, Chapter leadership and membership.



Cooperative Extension Systems Cultivate a Formal Relationship With State Associations of Counties

Across the nation over the past 10-15 years, there have been four state Cooperative Extension systems (Georgia, Minnesota, Ohio, and Pennsylvania) which have developed and cultivated a formal relationship with their respective state associations of counties. Although each position varies with regard to the job description and the details of the arrangement, the focus is roughly the same – to improve and strengthen the relationship between Extension and counties, at the statewide level.

In addition, the National Association of Counties (NACo), in partnership with the USDA National Institute of Food and Agriculture (NIFA) and the Association of Public and Land-grant Universities (APLU), has supported the Ralph L. Tabor Extension Fellowship for experienced Extension faculty since the late 1980's.

In late 2009, under the leadership of then-NACo Extension Fellow Keith Niemann from Nebraska, the four state Extension/state associations of counties fellows/liaisons came together to explore the commonalities of their jobs, as well as to explore the possibility of forming a national working group. In 2010, with leadership provided by Trudy Rice (the current NACo Extension Fellow) the working group was formally organized as *Aligning Counties and Cooperative Extension, or ACCE*.

ACCE has adopted the following set of guiding principles as it embraces its new mission:

- Sharing resources and ideas among Extension fellows to associations of counties on the national and state level
- Understanding different infrastructure of associations of counties and Cooperative Extension between states
- Promoting the partnerships as having a mutual benefit for Cooperative Extension and the Associations of Counties
- Assist associations of counties and their members by providing research based educational information related to emerging issues

In addition, members of the group are working to promote the fostering of additional state fellow/liaison positions around the country. Members of ACCE participated in a conference call of the Western Extension Directors in late January. Trudy Rice will be coordinating a presentation at PILD, along with Gwen Wolford (Ohio) and Jeff Christie (Georgia), and she also is coordinating a presentation at the Urban Extension Conference in Des Moines, Iowa, along with Judy Chambers (Pennsylvania) and Toni Smith (Minnesota). Each of these will be a panel presentation, and each will feature at least one Extension administrator. Additional opportunities are currently being explored with NACo, APLU, Extension Deans and Directors, and others.

Chapter Contacts Needed for Ad-Hoc History Committee

The Epsilon Sigma Phi ad-hoc History Committee is asking each ESP chapter to appoint a contact person who, each year, will gather and keep information and/or items to help preserve the continuing story of Epsilon Sigma Phi on the chapter as well as the national level.

Here are some ideas to help with this opportunity:

- Consider asking each chapter president to write a one-page synopsis of the highlights of their term as president.
 Include such things as award winners; issues that were discussed and dealt with by the chapter board; professional development opportunities offered through your chapter; what's happening in Extension in their state programming, delivery methods, funding issues.
- Save a copy of the chapter president's report that is submitted each year for the JCEP officer meeting.
- If your chapter has hosted a national ESP meeting, ask the involved members to write a paragraph each about their experiences with planning and hosting.
- Each year, keep a copy of such items as awards booklets, award winning applications, professional development fliers, newspaper clipping, printed web pages.

- Find the packrats in your chapter they will have many of the items you may want.
- Take photographs staged (award winner presentations) as well as "off the cuff" (members networking, teaching, enjoying fellowship). The photographer does not need to be you as the history contact person; you just need to get some copies of the photographs.
- Check your University archives to see what has been kept and what they currently gather.
- Develop a system for keeping the items: Do you keep the actual item in a file or box? Is the item scanned and kept electronically?
- Share what you have found with your chapter members.
- Share highlights with the national ESP History Committee.

These ideas can get you started. Good luck!
