# Professional Development Opportunities at the ESP Conference in Syracuse

The National ESP Conference scheduled for Syracuse in October is an excellent professional development opportunity. Specifically, there are events scheduled that will meet the professional development needs of all Extension professionals. The following is an overview of what will be offered to develop the Extension professional:



### Extension Reconsidered

Speaker: Dr. Scott Peters, Associate Professor of Educational Studies, Cornell University

We'll soon be marking two key historical moments: the sesquicentennial in 2012 of the first Morrill Act that established the land-grant system, and the centennial in 2014 of the Smith-Lever Act that established the cooperative Extension System. In this presentation, Dr. Peters will discuss how and why

we should use these anniversaries as opportunities to reconsider the meaning and significance of Extension's public mission, purposes, and work.

# Identity, Emotions and Language in Conflict over Public Issues

Speaker: Professor Poppy L. McLeod, Cornell University Department of Communication

This talk will focus on communication in conflict between societal groups over public controversies. Although everyone agrees that effective communication is key to resolving such conflicts, the general public is generally unaware of how emotional attachment to group identities and

ideologies can lead to subtle and unconscious expressions in their language of bias toward opposing groups. The talk will discuss how identity, values, emotions and language contribute to conflict between groups on different sides of public issues.

# Richard R. Angus Scholarship Applications Open Again

One of the benefits of membership in professional organizations is assistance in advancing in your profession. Epsilon Sigma Phi is here to help you do exactly that! As part of the Scholarships, Grants and Recognition program, ESP offers a variety of resources to help you attend the meetings you need, take a course or class that would help your programming, or get some well-deserved recognition for the work you've all ready been doing. Some of the offerings are fairly broad, such as a minigrant. For those you decide what you need to do, and apply for support to reach that goal. Others are more narrowly focused, such as the Award Recognitions for specific programs, or the scholarships for certain activities.

The Richard R Angus Professional Development Scholarships are offered to support Professional Development within Extension. As such they are meant to provide funds to enable the recipients to learn and improve their skills through participation in courses, seminars, conferences or workshops. As many as four \$500 scholarships could be given each year. This year the Board and Committee have decided to extend the application period until August 1, to encourage more members to take advantage of this resource. The funds must be used for study or training completed after the award is granted, so you can't use it to pay for something all ready done.

This scholarship is open to members whose dues are current and were paid the previous year. A letter of support from the Chapter

President and the immediate work supervisor are required in addition to the application. The applications are evaluated based on how well they follow the guidelines, on the relevance of the proposed study to the applicant's professional development within Extension, and to their state's Extension professional goals. The final point of evaluation is the level of involvement the applicant has demonstrated to ESP.

For more details on how the applications are evaluated and to apply, go to the ESP website. From the Home page, clicking on Recognitions-Applications-Reports on the top bar, and then on Scholarships will let you choose the Richard R Angus scholarship. The criteria for the grant and the type of projects it is intended to support are there. That page also gives you the links to the application form, which you complete on-line, and the links for the letters of support which are also supplied on-line.

There are surely more than a few members who have a training, a course or a workshop they would like to complete, but don't have the funds on hand to cover the costs! Why not rally your materials, confirm your support letters, and put in an application? It's a good opportunity to get some funding and some recognition to further your career today. Don't wait till the heat of July, do it today!

# PILD Meeting Highlights Reported by ESP PILD Scholarship Recipient

It has been several weeks since I returned to Indiana after attending PILD. I've had the opportunity to process the information that was presented and think about how to utilize that information in my job. I keep coming back to the presentation given by Dr. Marshall Stewart on "Impact Counts: Telling the Cooperative Extension Story to Stakeholders." I think this is the fourth time I have heard him give this presentation and each time it has impressed upon me the important job we have to keep stakeholders informed about the work we do. Dr. Marshall pretty well breaks it down to six points. They are: **3 Know's**: (1) know who you are, (2) know who you are talking to; and (3) know what is important to who you are talking to; and **3 Be's** (1) be flexible, (2) be relentless, and (3) be honest. We have to be prepared at all times to be able to give a short, 3minute speech to tell people what we do. In North Carolina, they focus on how Extension impacts economic opportunity, educational excellence and health and well-being. These are issues that Extension educates individuals about every day, but they also are important to elected officials. He also stressed the importance of always being thankful and what he calls the Rule of 7 - thanking someone seven different times, from seven different people, seven different ways. It is important that policymakers know we appreciate all they do to support Extension. He also shared the Rule of 12 - if twelve concerns come into the same office, it will get a response because it is constituent driven. This is why we have to involve our clientele to share the Extension story on our behalf.

The presentation reinforces why we need to be proactive in sharing with others what Extension is and what we do. It is imperative we educate our clientele to contact their elected officials to share the Extension story. Whether it is at the local, state or national level – our very future is depending on it!

# Kentucky's Alpha Kappa Chapter Celebrates "Pathway to Professional Excellence"

Each year Kentucky's ESP Chapter anxiously convenes to gain new information, receive awards and recognition, and for fellowship with current, new, and retired members. This year the Alpha Kappa Chapter in Kentucky hosted three separate events to support the chapter's goal of professional excellence. The Chapter hosted a Professional Development In-service Training Workshop and Local Foods Educational Dinner Program on March 22, and Annual Meeting and Awards Presentation on March 23, 2011. The meetings were held at the recently opened Center for Sustainability of Farms and Families located on the Kentucky State University Research and Demonstration Farm. The evening dinner was held in Midway, KY. Dr. Deborah Thomason, ESP National President, participated on both days with Alpha Kappa Chapter members who represent the University of Kentucky and Kentucky State University Cooperative Extension.

The theme of the professional development workshop was "We are the Agents of Change in Changing Times." Chef and co-owner, Ouita Michael, discussed and served a 3- course dinner made from fresh, seasonal ingredients produced by local farmers. A presentation was also given by a member of Francisco's Farm, an annual fine art and craft fair that draws thousands to Midway each June.

Over 150 members of the award winning Alpha Kappa chapter assembled on March 23 for a day of networking, poster sessions, a silent auction, awards ceremony, installation of officers, and memorial recognition. Duane Bonifer, Public Relations Director at Lindsey Wilson College served as guest presenter for the awards ceremony.


